I-9 compliance levels could not be measured

With I-9s being processed at so many locations, the only way for Shaw to evaluate overall compliance was to send someone out to do manual audits. "We didn't have the resources required for this kind of scrutiny," said Mark. "Yet we are very serious about employment authorization compliance."

Human error was inevitable

With 400+ hiring managers responsible for the accurate completion of what is a complex and highly time-sensitive form, human error is inevitable. "A paper I-9 process is subject to a large number of errors," said Mark, "including problems with completeness, accuracy, signature timing and legibility."

E-Verify was a separate process

With its strong commitment to ensuring work authorization, Shaw was proactively using E-Verify for all hires across all locations by 2008 - years before E-Verify was required at many of their locations. Yet re-keying I-9 data into E-Verify was one more manual process for the HR department to manage.

Re-verifications were difficult to track

"Each manager used his or her own method to track re-verifications," said Mark. "Our users were using location-specific tracking methods. This was another area prone to error."
