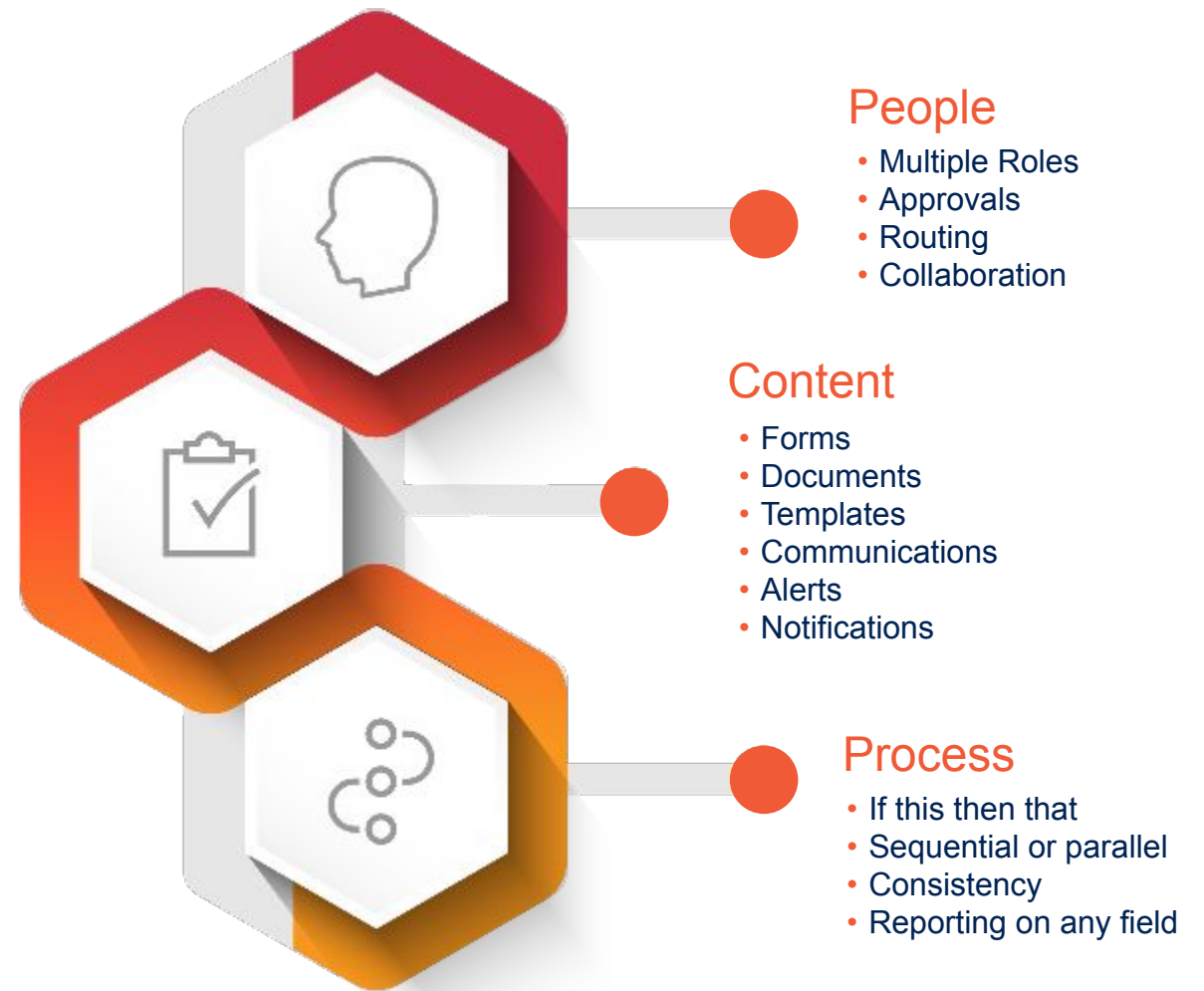

Five best practices for successful Workflow Automation

-  Continuously improve the process towards **perfection**



3rd Party Vendor Risk Assessment

Challenge:

3rd Party Vendor Risk was already an area of concern before COVID-19, but with the pandemic came a breakdown in supply chains.

Compliance teams needed to be able to ensure that 3rd party vendors were still operational and could deliver goods and services to prevent further disruption.

Results:

- Quickly survey current vendors with questions designed to assess the current risk status of each
- Survey results route to the correct department member who then validates the vendor's risk status and continuity plans
- Reduced impact on operations with proactive communication to assess and quickly mitigate vendor risk
- A secure, auditable, and confidential way of communicating with 3rd party vendors
