

I-9 Check-Up: From Arduous to Automated

The Opportunity

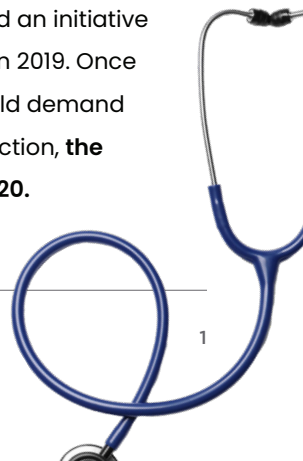
As a reputable Healthcare network, this organization securely oversees a significant amount of proprietary data – particularly between departments tasked with managing compliance. Between HR Compliance overseeing clearance records, an HR Solution Center fielding inquiries, a data team monitoring employee information and work assignments, and a special team of eight executing all pre-boarding and pre-hire screening requirements (including I-9 requirements), the enterprise had everything needed to support the employee and patient experience with full compliance

securely. But its primarily paper-based system – and the manual data management required to maintain it – was put to the test by the COVID-19 pandemic.

“With COVID, the whole dynamic of our world changed because now we’re remote and no longer meeting with people in person. So it became very challenging to train managers on how to properly collect information. We knew we needed an intuitive digital system – and that led us to Tracker I-9.”

Luckily, the team had already kickstarted an initiative to transition to an electronic database in 2019. Once it became clear that the pandemic would demand remote verification and document collection, **the team turned to Tracker I-9 in May of 2020.**
